Guidance note 1: For keeping and training animals for exhibition please provide information about the proposed performance(s) the animals will be exhibited or for which they are trained, including the apparatus which is used for the performance. If it is an animal encounter, please give details of what type of encounter and where they take place. Approximate duration of the performances, number of times the performance will be given on one day, how the animals are transported.

Selling animals as pets: please provide information about the type of business e.g pet shop, home sales, internet sales, wholesales, third party sales etc.

Hiring out horses: please provide information about the type of business e.g. riding school, trekking, hiring hunters, donkey rides.

Guidance note 1: Section 5. Licence holders for keeping and training animals for exhibition are required to have public liability insurance.

Licence holders for hiring out horses are required to have a public liability which insures the licence holder against liability for any injury sustained by, and the death of, any client, and insures any client against liability for any injury sustained by, and the death of, any other person caused by or arising out of the hire of the horse.
